

## **Standard One (1) Year Limited Warranty**

### **1. Limited Warranty Coverage**

Principal Lighting Group (PLG) warrants that SteriLED products are free from defects in materials and workmanship under normal use and conditions for a period of one (1) year from the original date of purchase.

PLG, at its sole discretion, will repair or replace the defective product at no charge if a product has been determined to be defective in materials or workmanship. PLG reserves the right to use similar, new, repaired, or remanufactured parts as part of the Standard Limited Warranty (“Limited Warranty”) process. The cost of labor or administration is not included under this Limited Warranty.

### **2. Limited Warranty Limitations**

This Limited Warranty is conditioned on proper use of SteriLED products and is voided if the products are used outside of their intended application or for the stated purpose or conditions for which they are designed.

This Limited Warranty does not cover (a) defects or damage resulting from accident, misuse, exposure to liquid or moisture; (b) defects or damage resulting from touching the light emitting diodes; (c) ordinary wear and tear; (d) defects or damage resulting from damage, deterioration, or malfunction resulting from any improper or unreasonable use or maintenance, improper testing, service or adjustment not furnished or approved by Principal Lighting Group; (e) defects or damage resulting from external causes such as collision with an object, fire, flooding, dirt, windstorm, earthquake, lightning, exposure to weather conditions, theft, or improper use of any electrical source; (f) any damage, deterioration, or malfunction resulting from any repairs attempted by anyone unauthorized by SteriLED to make such repairs; or (g) any other cause which does not relate directly to a defect in materials and/or workmanship of this product.

This Limited Warranty is void if the product is not purchased directly from SteriLED or distributed through SteriLED authorized dealers. ### **3. Remedies and Claim Procedures**

To obtain a remedy under this Limited Warranty, you must contact either the authorized SteriLED dealer from whom you purchased this product or the PLG office. To contact PLG, please call 325-227-4577 or go to the “Contact Us” link at [www.steriled.com](http://www.steriled.com).

Claims made for defective products must be made within one (1) year from invoice date.

- A. For replacement/repair service of an alleged defective product under this Limited Warranty, the purchaser must contact their approved SteriLED dealer or PLG for a Return Material Authorization (RMA) number and provide a proof of purchase for the product. RMA numbers may be obtained by calling 325-277-4577 or send us an email by going to the “Contact Us” link on our website.
- B. Once the RMA number is obtained, the alleged defective product shall be returned at the customer’s expense directly to SteriLED or the location designated by SteriLED at the time the RMA is issued. The product must be returned within thirty (30) days of RMA issuance for the RMA to remain valid. All shipping boxes and packing slips must be marked with the valid RMA number.
- C. If the product that is returned with the RMA is determined to be a defective product (at SteriLED’s determination with reasonable discretion), and covered by this Limited Warranty, SteriLED will provide the remedy outlined in this Limited Warranty and any replacement product will be provided with standard shipping at SteriLED’s expense.
- D. If the product that is returned with the RMA is not found to be defective by SteriLED, SteriLED will return the product to the customer at the customer’s expense.

#### **4. Exclusive Remedy**

THIS LIMITED WARRANTY AND THE REMEDIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, REMEDIES, AND CONDITIONS, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, WITH RESPECT TO THE PRODUCT OR PERFORMANCE. TO THE MAXIMUM EXTENT PERMITTED BY LAW, PLG SPECIFICALLY DISCLAIMS ANY AND ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

#### **5. Limitation of Liability**

THE MAXIMUM LIABILITY OF STERILED UNDER THIS LIMITED WARRANTY SHALL NOT EXCEED THE ACTUAL PURCHASE PRICE PAID FOR THE DEFECTIVE PRODUCT.
